Breaking Down Barriers to Economic Development

Job creation ... New business ... Global markets – words we use every day when talking about economic development. Local communities need to provide an environment for commerce to flourish. But is your county doing everything within its legal authority to encourage business development? Is it possible that local policies and regulations could be a barrier to economic expansion? This session will focus on the policies and regulations that counties control that impact the business community to provide an insight into decisions you make that could encourage ... or discourage ... economic development. You'll also hear about ways that you as a local leader can influence community decisions to help promote job growth and economic expansion.

How Personalities, Priorities and Politics Influence Decision-Making

Ever wonder why it seems the wheels of government move so slowly? Right now, Congress appears to be a good example of governmental inaction – is it just political ... or are personalities and individual agendas at play as well? Could it happen to your board of commissioners? This session will examine the dynamics of a board – personal styles, areas of conflict, or special interests that might inhibit the group from accomplishing community goals.
