Attorney General's Office Provides Clarification on Secure and Verifiable Documents On October 12, 2011, the Attorney General's Office issued a response to Representative Matt Ramsey's letter on whether secure and verifiable documents could be submitted to counties and cities electronically. Since the ACCG / GMA Joint Illegal Immigration Training Session on September 19, there has been much controversy as to whether it is permissible to accept such documents in this format or if applicants are required to provide these documents in person. The letter provides that because the language in the statute on this issue is ambiguous and that since this issue has not been challenged to the contrary that electronic submission of secure and verifiable documents is allowed for the time being and counties and cities that accept such documents will not be penalized. ACCG and GMA will be seeking to make changes to the statute next session so that it is clear that electronic submission of

documents is allowed. Please share this information to anyone in your county office who may be responsible for immigration compliance, especially anyone who deals with purchasing or the issuance of licenses or occupation tax certificates for the county. Two More Illegal Immigration Training Sessions Scheduled

ACCG and the Georgia Municipal Association (GMA) will hold two additional joint training sessions on Georgia's Illegal Immigration Reform and Enforcement Act (House Bill 87) on Wednesday, Oct. 26 (Emanuel County) and Thursday, Nov. 10 (Henry County) for counties and cities. These sessions will provide an overview of mandated local government immigration verification requirements. While E-Verify and SAVE compliance has been required of Georgia's counties and cities for three year, the passage of HB 87 during the 2011 legislative session imposes various new reporting mandates and penalties noncompliance, ranging from loss of qualified local government status, fines and possible jail time and removal from office for elected and appointed official. ACCG Schedules Four LOST Training Session

The Local Option Sales Tax (LOST) law requires counties and "qualified cities" receiving general purpose LOST revenue to renegotiate distribution agreements within two years of each decennial census. As such, "qualified cities" and counties must begin renegotiation of their distribution agreements on or before July 1, 2012. ACCG will host four LOST training sessions across the state which will cover history and purpose of LOST, techniques for effectively negotiating, requirements of the LOST law for renegotiation, how to measure the eight criteria required for consideration and formulas and methodology for creating the allocation. Remember to Submit Budgets and Financial Reports

Legislation passed by the General Assembly in 2010, requires all counties with budgets exceeding \$1 million to provide detailed financial information to the Carl Vinson Institute of Government. The Vinson Institute has developed a website giving local governments the ability to post financial documents, such as adopted budgets and audited financial reports. To date, only 46 cities, 26 counties and 116 school districts that have posted their FY2012 budget documents. Documents uploaded to the site must be in a PDF format. Once uploaded to the site and reviewed by the site administrator, the documents will be available to anyone with an Internet connection. Instructions on how to use the website are available here.
