GA Board of Natural Resources Accepting Public Comments on Proposed Changes to Dam Safety Rules

The Georgia Board of Natural Resources is currently considering revisions for Georgia's Rules for Dam Safety. This rule will greatly impact counties that own dams, particularly Category 1 dams – those that would potentially cause loss of life in a failure. Dam owners will have additional responsibilities in inspecting dams, repairing them if necessary, and creating emergency action plans, among other measures. Georgia EPD Accepting Project Applications for FY16 Section 319(h) Nonpoint Source Implementation Grants

The Watershed Protection Branch of the Georgia Environmental Protection Division (EPD) is now accepting project applications for FY16 Section 319(h) Nonpoint Source Implementation Grants. Funding is distributed via a competitive process to projects that will lead to direct reductions in pollutant loads and measurable water quality improvements. The maximum amount of individual Federal awards is \$400,000, over a maximum timeline of three years. Public agencies such as local, regional, or state governments; authorities that operate service delivery programs (e.g. sewer, water); regional development centers; agricultural conservation councils; and school and university systems qualify for grants.

The deadline for pre-application meetings is October 15, 2015.

The deadline to submit program applications is November 2, 2015.

Reminder: GTIB Grants Available

The State Road & Tollway Authority (SRTA) is now accepting grant applications for transportation infrastructure improvement funding. The SRTA announced in early August that \$29 million in

grant and loan funding is available for local governments and community improvement districts through the Georgia Transportation Infrastructure Bank program. The deadline to submit grant applications is **Monday, October 5**.

Counties Respond to Court Decision to Temporarily Block "Waters of the U.S." Rule

In late August, federal judges ruled to temporarily protect counties in at least 13 states – Alaska, Arizona, Arkansas, Colorado, Idaho, Missouri, Montana, Nebraska, Nevada, New Mexico, North Dakota, South Dakota, and Wyoming – from the implications of the "Waters of the U.S." rule. The decision temporarily stopped the U.S. Environmental Protection Agency and the U.S. Corps of Engineers from enforcing the new rule.

There has been debate about the scope of the ruling and whether it only applies to the said 13 states or nationally. The National Association of Counties has issued additional information on this issue since the initial ruling. Click <u>here</u> for further information.
