Currently residing in Oxford, Sherlock is deeply committed to her community. As a Certified Peer Specialist in Addictive Diseases and Mental Health, as well as a Forensic Peer Mentor, she brings a wealth of personal and professional experience to her work. At the Georgia Council for Recovery, Sherlock travels statewide, facilitating Recovery Oriented Systems of Care and Certified Addiction Recovery Empowerment Specialist (CARES) Workshops. Her passion lies in walking alongside peers as they embark on their journey to becoming CARES, fostering connections and understanding during the transformative week at the CARES Academy.

Judge Nancy Bills was appointed by Governor Brian Kemp to fill the vacancy in the Rockdale Judicial Circuit Superior Court when Chief Judge David B. Irwin in the fall 2020 and was sworn in on February 22, 2021 to fill his unexpired term. She was re-elected in 2022.

Beginning in February 2021, she is the Judge presiding over the Adult Drug Court in Rockdale County. Prior to being appointed to Superior Court, she served sixteen (16) years on the State Court bench where she founded a DUI Court in 2007 and presided over that Court until 2021. DUI Court was named a Model Court in 2020 by the Council of Accountability Court Judges. While in State Court she also founded and presided over Domestic Violence Court from 2013-2021. Before being elected to State Court in 2004 she served as an Assistant District Attorney for over 10 years before leaving for private practice where she practiced criminal defense and family law for 5 years.

Currently, Judge Bills serves as Vice-Chair of the Criminal Justice Coordinating Council and is Chairperson of the Rockdale County Task Force Against Family Violence. Judge Bills graduated Cum Laude with a BA Degree from UGA and then Cum Laude from Law School at UGA.
