George Alexander was elected and served on the Newnan City Council from November 2003 to January 2024. As a City Councilman, Alexander was responsible for an annual budget of \$35 million. He prided himself on his shared responsibility for safety of Newnan's 45,000 citizens as well as setting and implementing policy for the city. He also served on the Newnan Planning Commission from 1989-2003, including ten years as its elected Chairman.

He was born in El Paso, Texas and as the son of an Air Force Colonel, he lived throughout the United States. He has resided in the Greenville Street Historic District for 39 years. He is a retired Delta Pilot with 35 years of service.

He is a 1976 graduate of Texas A&M where he attended on a four-year Navy Scholarship. He earned a BBA in Business Management. He served in the United States Navy for 25 years in active and reserve roles as a Naval Officer and as a Fighter Pilot flying on and off aircraft carriers. He is a graduate of the U.S. Navy Post Graduate School, the Naval War College, and the Air War College. George has been an Eagle Scout since 1967.

Alexander is active in his community, including having served as a distinguished past president of the Newnan Kiwanis Club and a current Board of Directors member, a Community Action for Improvement (CAFI) Board member, a life member of the VFW and American Legion, a District Chairman for the Coweta County Boy Scouts and Eagle Scout Board of Review member, a past Board member of the Summit Family YMCA, a past Board member for the Newnan Boys and Girls Club, a past Board member and Chairman for the University of West Georgia, Newnan Campus. He also has completed 315 hours of continuing education training for the Georgia Municipal Association – earning a Certificate of Dedication – an achievement earned by only 1% of all State of Georgia City Elected Officials.

Angela Holt has served as the Chief Executive Officer of Middle Flint Health & Wellness since 2020. She has worked for Middle Flint Health & Wellness for over 18 years serving in many capacities, including Medical Records Clerk at the Americus Outpatient Clinic, Administrative Assistant for an Executive Staff member and Operations Analyst/Statistical Technician position in the Utilization Management department. She was then transitioned to the position of Director of Information Technology/Management of Information Systems (IT/MIS), Total Quality Management (TQM), and Utilization Management (UM) Coordinator.

In 2014, the Bridge Services Unit was formed. The intent was to develop a unit that bridges direct service units with the administrative and financial units. In this department, Holt was responsible for the IT/MIS, UM as well as quality assurance and risk management functions. In 2017, she was promoted to Chief Operations Officer and assisted in the acquisition of Phoenix Health Behavioral Services which provided services to Houston, Peach, and Crawford counties. This brought Middle Flint from being an eight-county community service board to being the safety net provider for eleven counties.

Holt was born and raised in Americus, Georgia but spent 10 years serving in the U.S. Air Force as a Munitions Systems Craftsman. During her career in the Air Force, she attended Air Force Leadership School and was inducted as a Noncommissioned Officer in the grade of Staff Sergeant, on February 1, 1999. She also received the Armed Forces Expeditionary Medal for Serving as Chief Munitions Control Officer on December 29, 1999. After an honorable discharge, Angela moved back to Americus in 2000 and was hired at Middle Flint Health and Wellness in 2003. She has a Bachelor of Business Administration from Georgia Southwestern State University and an MBA – Executive Option from the University of North Alabama.
